#### Definition and Indication: FOOD FOR SPECIAL MEDICAL PURPOSES

For dietary management of drug-resistant epilepsy on ketogenic diet, glucose transporter type 1 deficiency syndrome, and pyruvate dehydrogenase deficiency.

#### Ingredients:

water, vegetable oils (medium chain tryglicerides from plam fat and coconut fat in varying proportions, safflower oil, linseed oil), pea protein, flavours, chicory inulin, tri-calcium citrate, emulsifiers: mono- and diglycerides of fatty acids, sucrose esters of fatty acids; skimmed cocoa powder 0,7%, DHA-rich oil from microalgae Schizochytrium sp, magnesium citrate, potassium carbonate, acidity regulator: lactic acid; potassium chloride, choline bitartrate, I-carnitine I-tartrat, vitamins (C, E, A, D, pantothenic acid, niacin, biotin, folic acid, B6, B12, K1, maltodextrin), sweetener: sucralose; taurine, inositol, iron sulphate, zink sulphate, manganese sulphate, copper sulphate, sodium selenite, potassium iodide, chromium chloride, sodium molybdate.

#### Important notices

Use under medical supervision.

Not for parenteral use.

Not to be used by individuals who do not have the specific disease.

Suitable for the use as a sole source of nutrition from 3 years of age or as a supplement over the age of 10 years.

#### Dosage

To be determined by the clinician or ketogenic dietitian and is dependent on the age, body weight and medical condition of the patient. KetoEpi should be introduced slowly into the diet as rapid absorption of large intakes may cause vomiting or diarrhoea.

#### Contraindications

KetoEpi should not be used when ketoacidosis/acidosis, decompensated liver cirrhosis, chronic kidney disease is suspected or in patients with metabolic disorders (MCAD-, VLCAD-, LCHAD-, CPT1-, CPT2-, CACT-deficiency).

### Preparation guidelines

According to the instructions of the physician or nutritionist, the product may be administered orally or through a feeding tube. If the product is administered orally, then best enjoyed cold. Shake well before use.

#### **Storage**

Unopened: Store at room temperature. Once opened: reseal the unused portion, store in the refrigerator and use within 24 hours or within 6 hours at room temperature.
