

KetVit is a ready-to-eat, firm food containing dietary fibers and a blend of mediumchain triglycerides (MCT) in a ratio of 5.7:1 of fat to carbohydrates and protein. It contains sugar and sweeteners.

Definition and Indication: FOOD FOR SPECIAL MEDICAL PURPOSES

For dietary management of pharmacoresistant epilepsies within the context of ketogenic dietary therapy and rare cerebral energy metabolism disorders such as GLUT1 deficiency and pyruvate dehydrogenase (PDH) deficiency.

Ingredients:

medium chain triglycerides 24,5% (from palm kernel and coconut fat), thickener: cellulose; palm fat, **hazelnut** paste 9% ('**Nocciola** Piemonte PGI'), cocoa butter, vegetable fibres (chicory inulin, soluble maize fibre), cocoa powder 6%, sweeteners: erythritol, sucralose; **milk** protein 3,6%, **soya** protein, emulsifier: mono- and diglycerides of fatty acids; tricalcium phosphate, sunflower lecithin, natural vanilla flavour, vitamin mix (C, D3, maltodextrin, E, niacin, A, pantothenic acid, folic acid, B6, B12, B2, B1, K1, biotin). May contain traces of lactose **(milk)** and other **nuts**.

Important notices

Use under medical supervision. Not for parenteral use. Not to be used by individuals who do not have the specific disease. Suitable from 3 years of age onwards. Not suitable as a sole source of nutrition.

Dosage

To be determined by the clinician or dietitian and is dependent on the age, body weight and medical condition of the patient. KetVit should be introduced slowly into the diet as rapid absorption of large intakes may cause vomiting or diarrhoea.

Contraindications

KetVit should not be used if ketoacidosis/acidosis, decompensated liver cirrhosis, chronic kidney disease is suspected or in patients with metabolic disorders (MCAD-, VLCAD-, LCHAD-, CPT1-, CPT2-, CACT-deficiency)

Preparation guidelines

Ready to eat with a spoon or to be spead over bread or used in other recipes.

Storage

Closed: Store in a cool place at room temperature between 18°C and 20°C, keep dry. Protect from sunlight and other sources of heat. Opened: After opening, close the lid tightly again, store at room temperature between 18°C and 20°C, protect from sunlight and other sources of heat. Consume within 5 days after opening.
